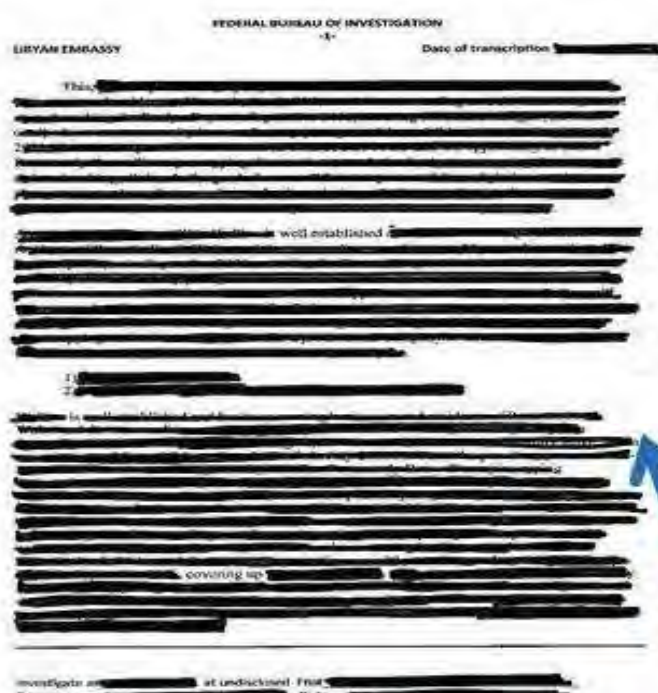

The FBI Transcripts of interviews with Benghazi survivors were turned over to the Senate Intelligence Committee last Thursday, Feb 1, 2013. The documents came from the White House and is the second set to be sent to Congress.

Then, Hillary Clinton's State Department approved these countries' weapons deals.

Despite her vaunted 30 year track record in & around government, Hillary Clinton has a funny & largely underreported habit of illegally destroying or removing federal records; often while she's under investigation

In 1994, during Clinton's time as First Lady; Federal prosecutors subpoenaed documents from Hillary's former law firm as part of an investigation into shady land deals in what is known as the "Whitewater" Scandal

These documents immediately went missing, only to be found 2 years later in Clinton's private quarters in the White House; FBI analysis would later find Hillary's fingerprints on the files

A witness also testified that he destroyed a box of Vince Foster's files for the Rose Law firm just as the case went public; Foster also worked at the firm & was a potential co-conspirator who committed suicide 6 months before subpoenas were issued

No Record, No Crime

In an interview with Time, FBI director & former prosecutor James Comey revealed that Hillary was personally involved in mishandling documents & ordered others to block investigators as they examined the 1996 Whitewater scandal; Comey also added that these acts were "far more than just aggressive lawyering or political naiveté" but were instead "a highly improper pattern of deliberate misconduct"

Despite being required by law to preserve all work-related documents from her time as Secretary of State; Hillary Clinton ordered her lawyers to destroy thousands of emails, some work related, with a program designed to wipe data permanently - FBI records show these emails were likely under subpoena at the time & the Oversight Committee has asked the DC U.S. Attorney to investigate Clinton & her aides for destroying evidence & obstruction of justice

As part of a July deposition, top Clinton aide Huma Abedine revealed under oath that Hillary placed some of her schedules as Secretary of State in "burn bags" - thereby illegally destroying federal records

During the investigation into Clinton's unauthorized, private email server, the FBI discovered that she couldn't produce 13 mobile devices she'd used with the server; including 8 Blackberrys & 5 laptops; only two of the devices could even be accounted for; an aide testified he'd "smashed them with a hammer," the other devices simply vanished

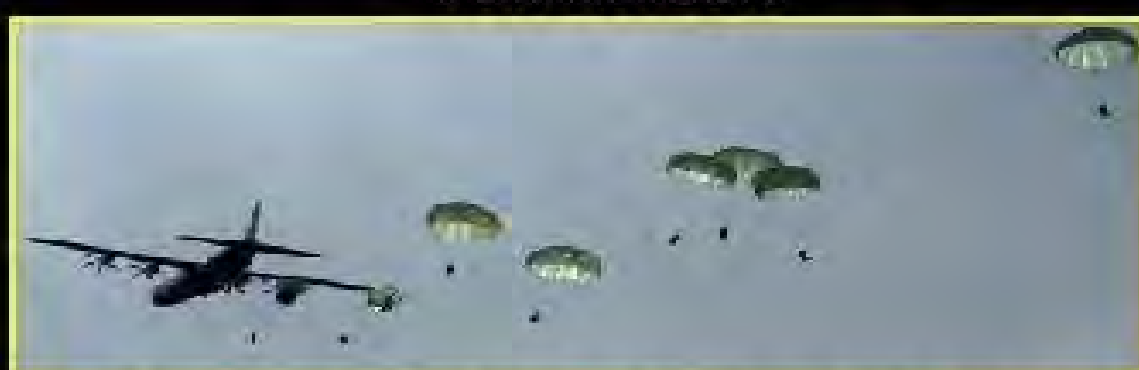
