The following is adapted from a talk delivered on July 23, 2024, at Hillsdale College's Blake Center for Faith and Freedom in Somers, Connecticut.

IN MARCH of this year, Bryan Malinowski, the executive director of the Bill and Hillary Clinton National Airport in Little Rock, Arkansas, was killed by agents of the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) during a pre-dawn raid of his home. It was an unwarranted and indefensible killing of a kind that should never, ever happen in a free country like the United States. Because we have a media that no longer serves in its traditional role as a government watchdog, this incident was not widely reported. Because too many members of Congress no longer take seriously their responsibility to protect the rights of those who elect them, the ATF has suffered no repercussions.

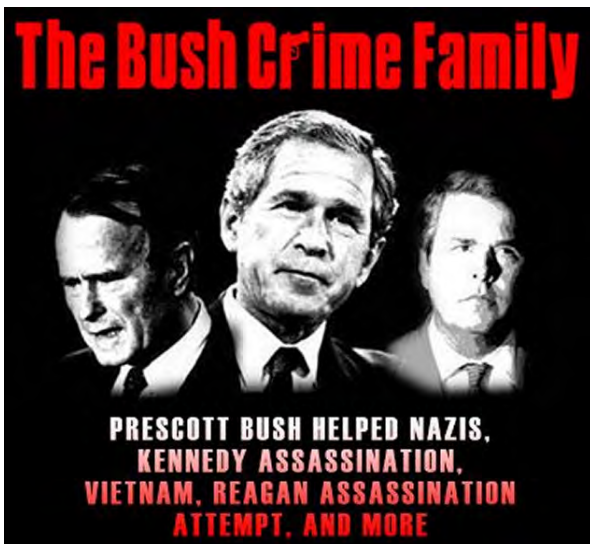
Therefore violations of our U.S. Constitutional Supreme Law along with all conforming (and not conflicting) laws are both unlawful AND illegal!

And once we have allowed the most powerful branch with the law enforcement function to have become corrupted, it has now been allowed to spread to the other two.

We cannot have the **LAWLESS** criminals responsible for enforcing the **SUPREME LAW** upon themselves.

CONSIDER THIS: We already have a 'Fourth Branch of Government'. This 'fourth branch' is often referred to using various terms, such as 'The Deep-State', 'The Shadow Government', 'The Bureaucratic Administrative State', 'The Military-Industrial Complex', 'The International Banking Cartel Puppet Government', 'The Corporate Government', or 'The Alphabet Mafia'. These are terms related to both the elected, unelected, and both have become unaccountable.

TO USE A METAPHOR: A 'Four-legged Stool' is much more sturdy, stable and balanced than a 'Three-legged Stool'... If you are sitting on it when one of the legs breaks, you will fall right to the floor. If you are sitting on a 'four-legged stool' when the one of the legs breaks, then all you would need to do is to just shift your weight toward the side with the three remaining legs, and then you will not fall, and the 'stool' is still essentially usable until you can fix that broken leg.

AND TO USE ANOTHER METAPHOR: If you have a 'bank robber' running out of a bank with a big sack of money, are the police required to 'file a lawsuit' and 'issue a summons' to the crook and wait to see if he'll show and judgment be issued in order for the law to be enforced? Then why do we allow public officials to obviously violate the laws and rob the people of their rights?

AND IF THE FOUNDERS WERE ALIVE TODAY to see just what has become of their creation, with the hindsight they didn't have that we have now, I think they would fully agree that there was just one more critical 'Separation-of-Powers' that they had missed...

The actual root of the problem lies in the fact

that even though our entire legal system with all the laws that are supposed to be in conformance and do not conflict with our U.S. Constitution are actually founded upon that same **SUPREME LAW**.

And even so, we have absolutely no agency, mechanism, or entity with the authority to actually **ENFORCE THE SUPREME LAW** upon those that we have allowed into public office and public service. And now as we see they are beginning to impose an increasing surveillance, security and police state upon the citizens who have been dumbed down and disengaged over the years enough to have allowed these conditions to emerge and develop in our now 'watered down' republic. What we need to do is to 'turn the table' by imposing a virtual 'surveillance and police state' upon our public servants because right now we see that there is no discipline on those in the 'public trust' in office or in the bureaucracy.

And as far as I can see, it has actually been a systemic problem that has just continually grown since the founding of our country, because considering the fact that we now have the hindsight our founders did not have at that time, there was just one more 'separation of powers' that they had neglected to institute in the establishment of the three branch structure of our government.

When you consider that government power has basically two functions which involve the use of force—and potentially even deadly force—is 1) the military, and 2) law enforcement. Now, both of these powers of force just happen to reside in the same branch—the Executive Branch. Then, when you consider that should that one branch become infiltrated, compromised, corporatized, politicized and corrupted by criminal and treasonous elements as individuals in key positions from outside influences and forces, it only stands to reason that your law enforcement and military entities would become corrupted over time as well. And when this happens as we can now see much more obviously today, it spreads to largely corrupt the other two branches as well.

HOW WE CAN SECURE AND ENFORCE THE CONSTITUTION AS ESTABLISHED SUPREME LAW

When those that have been granted 'the public trust' to serve in an official capacity in any office that operate based solely upon an ideological or political basis outside of established law are not in service to the people governed, and should be held strictly accountable to that same law.

In order to avoid corruption, a government that operates strictly by established law and policy is one in which politics should be isolated only to how one attains office, but not how government operates.

SO WHERE ARE THE ARRESTS???

It appears that EVERYONE from our government officials, to the media, to the educational system, to the public has not been informed or simply ignores the fact that OUR U.S. CONSTITUTION, which includes OUR 'BILL OF RIGHTS' is 'SUPREME LAW' as established in Article VI, Clause 2 of the same, which is absolutely NEVER ENFORCED. Why is it that whenever someone mentions the word "Constitution", they never also include the words AND THE FACT that it is the "SUPREME LAW" in the very same sentence?... And this also includes people that should know better such as Constitutional 'Law' attorneys and college professors.

Elizabeth Willing Powel asked Benjamin Franklin the question; "Well, Doctor, what have we got, a republic or a monarchy?" And he responded...

"A 'Republic', if you can keep it."

And, he should have added... "...And a 'Supreme Law', if you can ENFORCE it!"

Executive, Legislative, Judicial, and **CONSTITUTIONAL LAW ENFORCEMENT!**

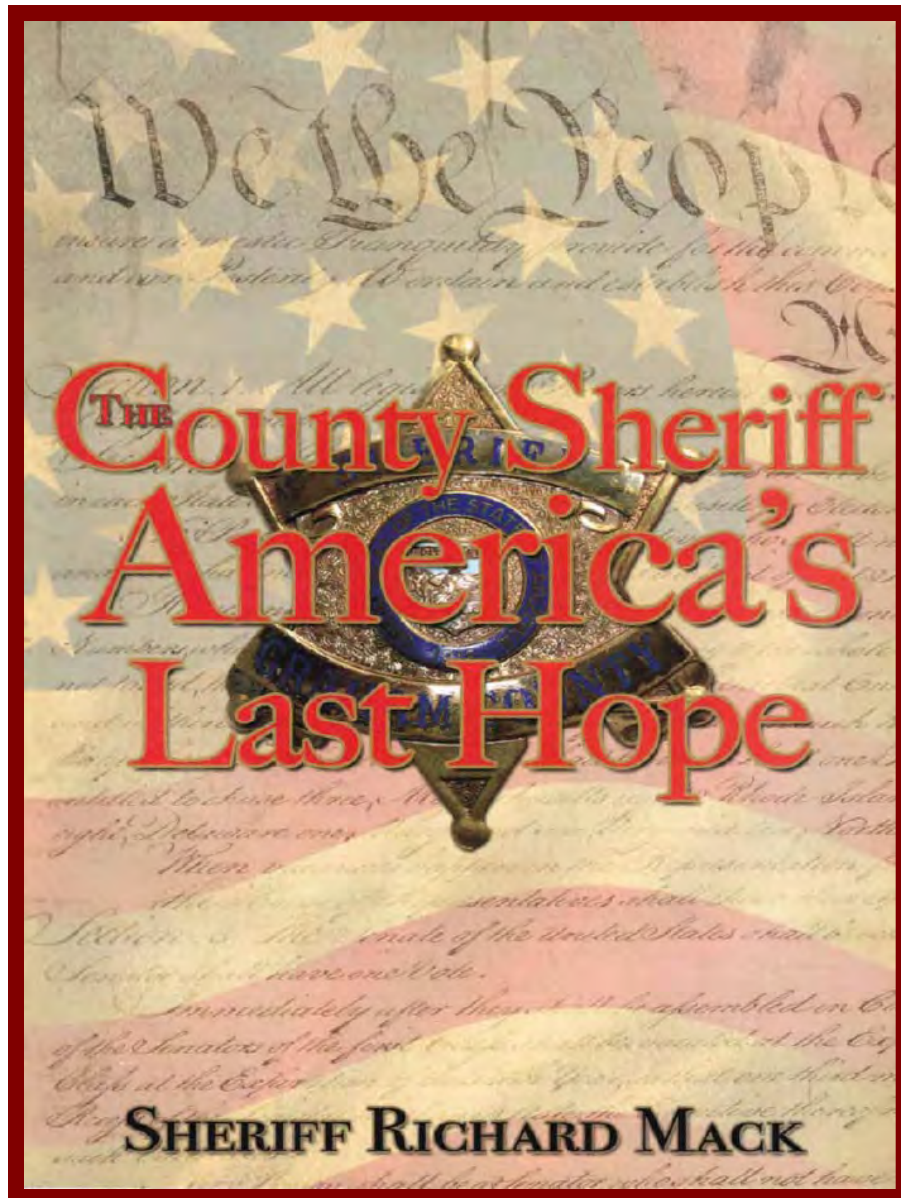
THERE IS NO LAW ENFORCEMENT AGENCY

The DOJ, FBI and the 'Inspector Generals' are basically useless!

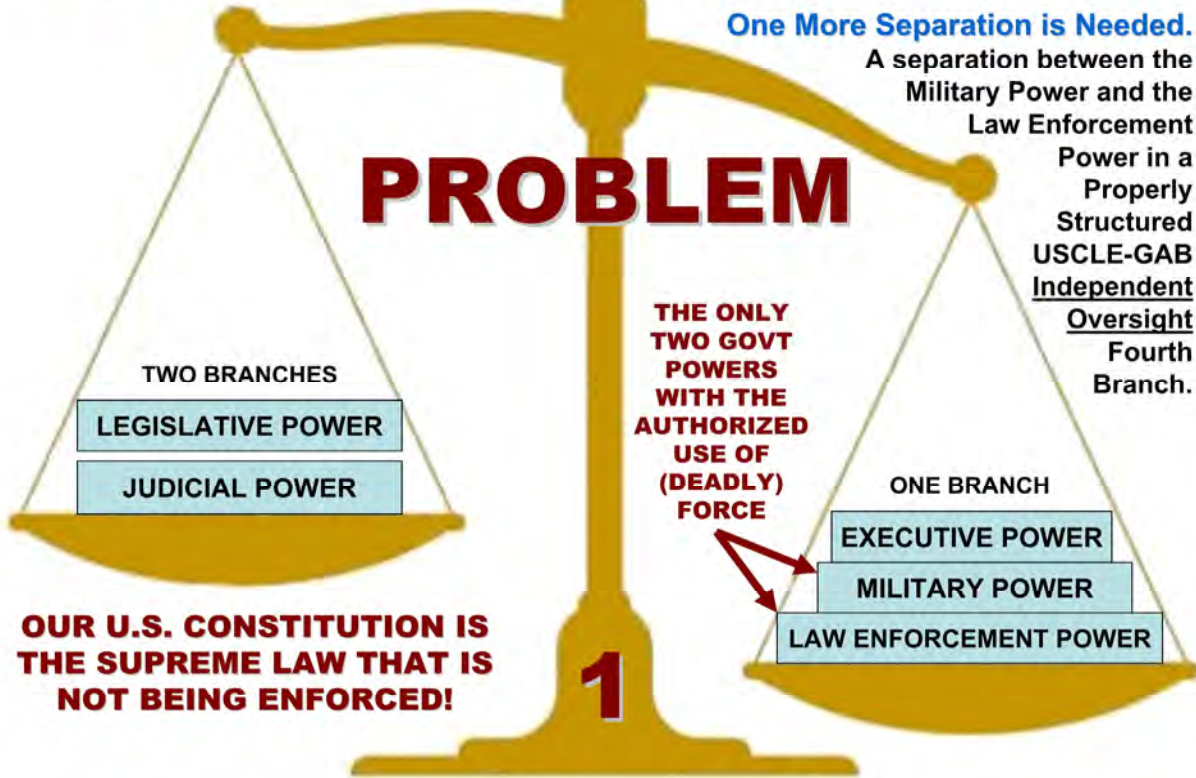

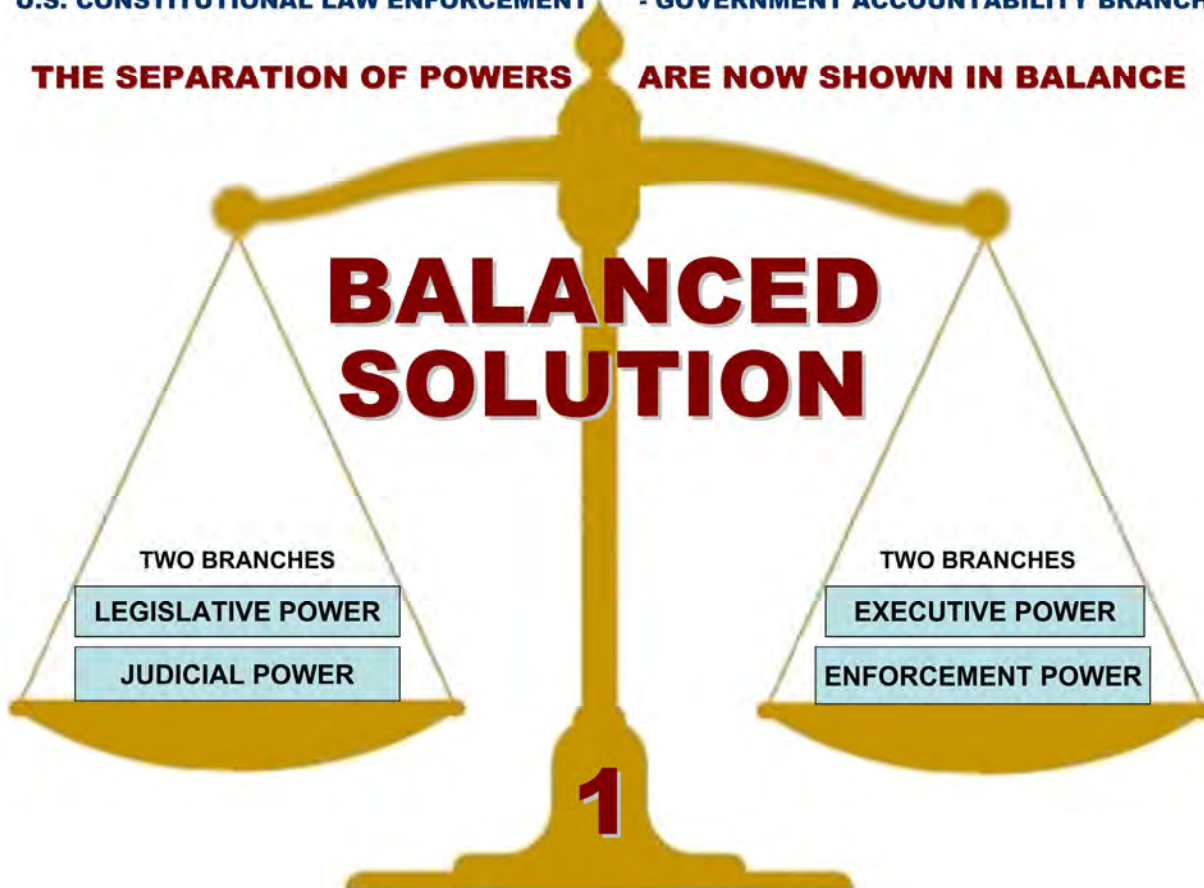

THE SEPARATION OF POWERS ARE NOW SHOWN IN BALANCE



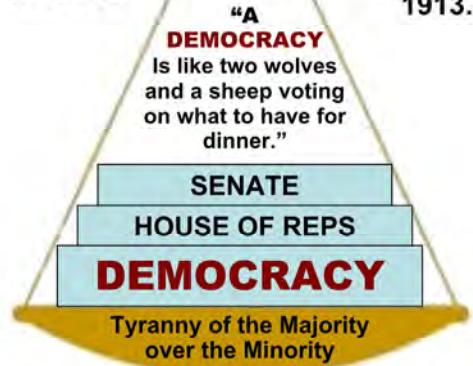
OUR FOUNDERS WISELY STRUCTURED THE BALANCE BETWEEN A REPUBLIC

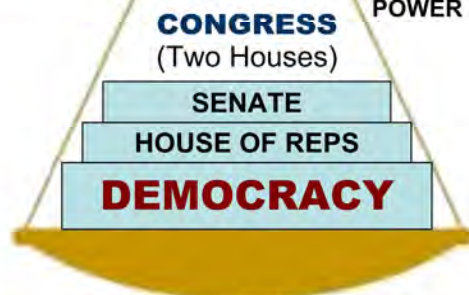

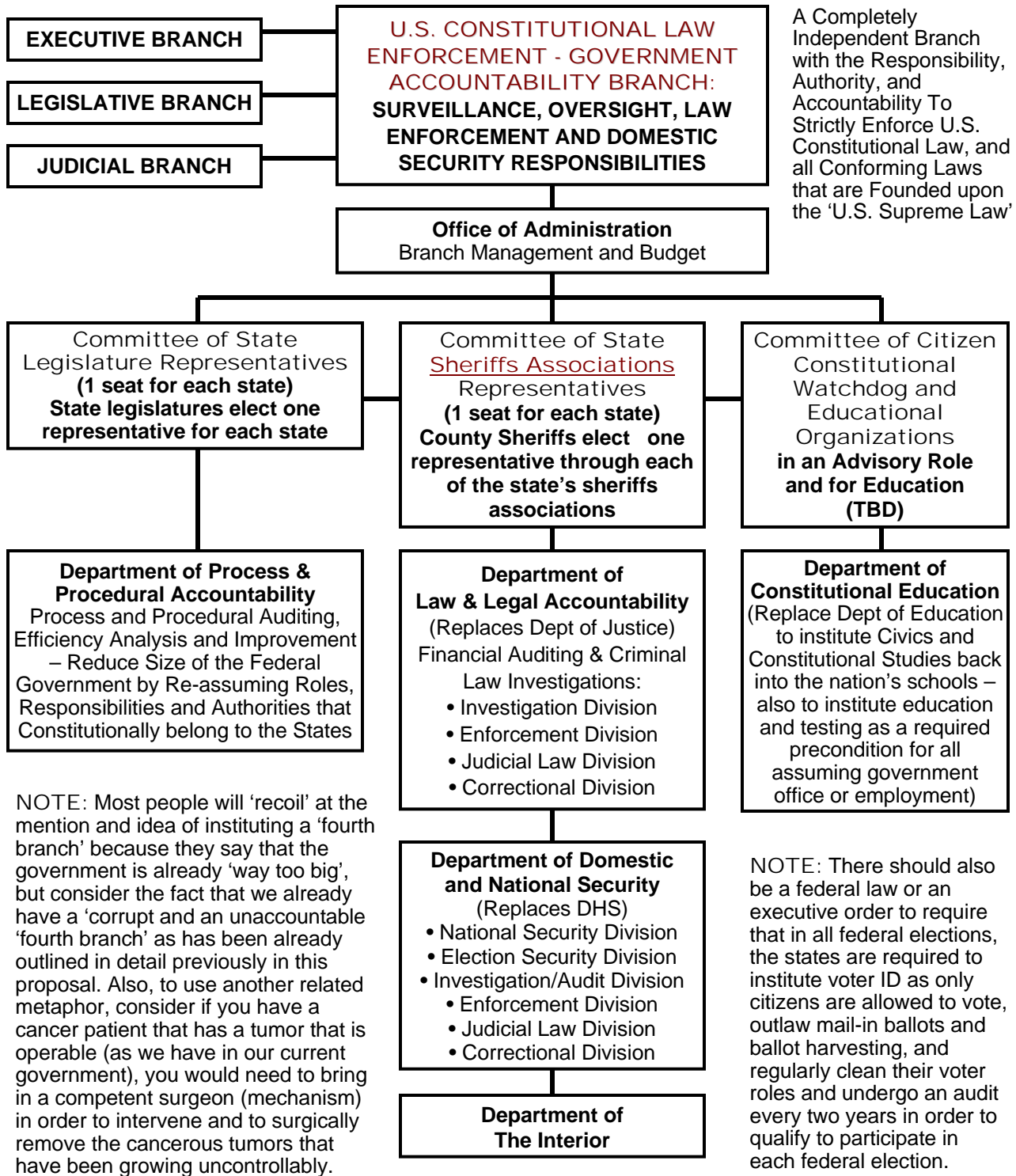
